The NSPCC ChildLine Schools Service has been updated and will now be called Speak Out. Stay Safe. The programme uses specially trained volunteers to talk to primary school children about abuse using interactive and memorable presentations. The programme is delivered through an assembly presentation of 20-30 minutes for each age group

(followed by a 1 hour classroom workshop for years 5 & 6). The aim for the sessions is to help children:

- understand abuse in all its forms and recognise the signs of abuse
- know how to protect themselves from all forms of abuse

• know how to get help, and the sources of help available to them, including our the ChildLine service

New Sexting Guidance for Schools



With more than 2000 children (some as young as 12) reported to the Police over indecent image offences during the last 3 years, the need to educate young people about keeping themselves safe online is more important than ever. Young people today are entirely comfortable with sharing their entire lives online.

Whilst this 'share all' culture has benefits, it also creates an environment where young people share and do things that they would not normally do in the 'real world' without thinking about the possible consequences. The law states that making or sharing indecent images of anyone under the age of 18 is a criminal offence – however there have been calls for recording rules to be adapted so that children are not routinely criminalised. New guidance 'Sexting in schools and colleges: responding to incidents and safeguarding young people' has been published by the UK Council for Child Internet Safety (UKCCIS) ('alerted' to

KAHSC subscribers 8th September 2016). The guidance, referred to in 'Keeping Children Safe in Education' Sept 2016, has been created to support schools in developing procedures to respond confidently and quickly to incidents involving 'sexting'.



5 simple safety tips that will cost you nothing but could save you plenty...

1. Adjust the back rest of your office chair to support your lower back (lumbar area).
2. The longer you sit at a computer, the more you edge to the front of your chair and lean forward – this can lead to back strain. Ensure that you sit at the back of your chair with the backrest supporting your back.
3. Ensure that your monitor is roughly an arm's length away with the top of your screen at approximately eye level.
4. Avoid reaching for your mouse or keyboard. The mouse should be at a comfortable distance to the side of your body. When typing your elbows should be at approximately a 90 degree angle.
5. Avoid cradling the phone between your neck and your shoulder – a sure way to lead to aches and pains.



Practical science chemical safety

A Department for Education bulletin has been issued to remind all settings of the importance of ensuring all chemicals used for practical science activities are stored safely. CLEAPSS has recently received a number of calls regarding a particular

chemical - 2,4-DNP (2,4-dinitrophenylhydrazine). Settings should check their stocks as soon as possible and dispose of chemicals appropriately. Advice on the safe storage of chemicals can be found on the CLEAPSS website.



IN COURT:

Essex School fined after refurbishment disturbs asbestos



An Essex Academy has been fined after poorly-planned refurbishments exposed school staff and others to asbestos. School management had decided to convert an old boiler room into a cleaning store.

During the course of the works asbestos residue on the walls was disturbed and the caretaker swept the contaminated debris from the floors. Exposure to the risk was only identified after a later asbestos survey was completed in the area.

The HSE found that asbestos containing materials were also present in other areas of the school and had been disturbed numerous times over the years by school care-taking staff and contractors, all of whom were put at risk of developing

serious health conditions arising from exposure. The Academy Trust was also found to have failed to ensure the spread of asbestos was prevented or reduced, by implementing suitable precautions to prevent its disturbance and making sure that those liable to disturb the materials were made aware of its location.

They pleaded guilty to breaching the Health & Safety at Work Act 1974 and was fined £26,000 and ordered to pay costs of £20,000.

School fined for safety failings at Summer Camp

A seven year old boy attending a Summer Camp run by St Edmunds School, Canterbury got into difficulties whilst taking part in a scheduled swim. He struggled for 3 minutes before becoming motionless in the water.

Lifeguards at the pool noticed that he was in trouble and retrieved him from the water. He regained consciousness after CPR but did develop pneumonitis as a result of the incident.

An HSE investigation found that the lifeguards were not effectively managed and monitored to ensure that they were constantly vigilant.

Two of the three lifeguards did not hold a current, in date lifeguard qualification.

The school pleaded guilty to breaching the Health & Safety at Work Act 1974 and was fined £18,000 and ordered to pay costs of £9670.



Planning for the winter months...

The severe weather conditions of the winter months can disrupt the workings of educational establishments in a number of ways.

It is vital that Heads, Managers, the Principalship and Governing bodies plan ahead and determine procedures to ensure the safety and well-being of all young people and staff and that all employees are clear about their roles and responsibilities in the event of severe weather.

Slips, trips and falls are a regular occurrence during the winter months as a result of icy/snowy conditions, leaves and moss, unsuitable footwear, changes from wet to dry flooring and insufficient lighting:

- Entrances which take priority for clearing to allow safe access to the premises must be identified and parents and others informed of which to use in severe conditions
- If possible close off walkways which are not a priority
- Identify which walkways or areas need to be kept clear during the day to allow everyone to get around the grounds safely
- Install suitable mats to keep internal floors dry
- Ensure that external lighting is sufficient and light the appropriate areas such as walkways and car parks
- External lighting should be checked regularly to ensure that it is functioning properly on dark mornings/nights and any faults rectified as soon as possible to allow safe entrance and exiting of the building.

Whilst cold weather can cause serious damage; freezing and bursting pipes where not appropriately lagged, or where heating systems have not been on a 'frost control' or low setting; high winds can cause damage to property and grounds and make unsecured objects such as bins 'flying hazards'.

Where school has been closed during periods of severe weather adequate checks should be made on the heating system, pipework, ceilings and roofs to ensure that no damage has been caused. Hanging your Christmas decorations & displays safely



In the past Health and Safety has been blamed for ruining many a joyous occasion including the hanging of decorations and displays. Bah humbug!!

So long as people are sensible about these activities, there is no reason why your halls can't be decked with the spirit of Christmas. To avoid a festive trip to A&E below are a couple of Dos & Don'ts...

DO:

- Use a sturdy, well-maintained stepladder – not your wheelie chair!;

- Wear footwear with a good grip – smooth or wet soles and high heels are not suitable for working at height;
- Fully extend extension cables/reels so that they don't cause a trip hazard;
- Ensure that the tree is stable.

DON'T:

- Try to hang your decorations on your own - have someone assist or at least in the vicinity;

- Over reach – when working on stepladders you should always keep 3 points of contact so as to maintain your balance;
- Hang decorations over/ across ceilings on escape routes;
- Use lighted candles as part of your displays.
